The Right to information Act, 2005 was promulgated by the Government because democracy requires an informed citizenry and to bring transparency of information which are vital to its functioning and also to contain corruption and hold the Governments and their instrumentalities accountable in discharging the public duties.

As per Section 5(1) of the Right to Information Act, 2005, every public authority shall designate Public Information Officers in all the administrative units/offices to provide information to the persons seeking information under this Act.
